Purpose/Scope: Provide individuals with disabilities access to electronic information, including documents and web pages, that resides in the State of Nevada Content Management System (CMS) in accordance with the World Wide Web Consortium (W3C) Web Content Accessibility Guidelines (WCAG) 2.0 Levels A & AA, and the Web accessibility Rich Internet Applications Suite (WAI-ARIA) 1.0 for web content.

Consequences, deficiencies or gaps if not completed or project slips significantly:

State of Nevada web content and documents will not be accessible to individuals with disabilities as required by the federal American Disabilities Act (ADA)

Challenges: The scope of this effort is very large. Remediation efforts will include 132 websites, 23,849 pages of web content, and 75,609 PDF documents.

## Project: Office 365 State Tenant

Purpose/Scope: Creation of a shared infrastructure for the State of Nevada so all State agencies can interoperate on a common set of Microsoft Office tools within a common user identity system.

Consequences, deficiencies or gaps if not completed or project slips significantly:

Not completing this project will result in State agencies operating under disparate versions of common business software. This reduces efficiencies in collaboration and agency interoperability and increases overall costs to the State.

Challenges: Staffing – Since the last ITAB meeting two (2) technical and two (2) PMO resources have been added to the team to assist with implementation of the O365 collaboration tools.
 Governance – The committee has been created, met in October 2018 and will meet monthly.
 Scheduling – Scheduling the implementation for close to 18,000 users statewide has been a challenge due to budget constraints. This challenge has been mitigated through the development of the 2020-2021 biennial budget.
