This document contains the current list of technologies, including hardware, software, vendors, and services, that are banned from use in the State of Nevada due to security concerns.

2.0 SCOPE

This Banned Technology list applies to all state agencies and authorized users meeting the criteria identified in the State Information Security Program Policy, Section 1.2, Scope and Applicability.

3.0 EFFECTIVE DATES

This standard becomes effective at the time of approval by the State Information Security Committee (SISC).

4.0 RESPONSIBILITIES

The agency head and appointed Information Security Officer (ISO) have the responsibility to ensure the implementation of and compliance with this list and its associated standard.
